4.6 Geographical Localisation

The Geographical Localisation must be seen as a compulsory security measure as any other security device such as the harnesses or other. It is, therefore compulsory.

During the whole rally, cars will HAVE TO be equipped with a tracer which will be given during Technical scrutineering before the trial in exchange of a deposit of **200 euros** (cheque or cash)

This deposit will be given back after returning the tracer according to the instructions given with the tracer.

The league commits to giving back this deposit even if the tracer would be totally destroyed or damaged in case of any **accident** during the rally.

No rental of any kind is needed. The operating costs are borne by the league.

The instructions and kit to fix the device is free of charge and will be given during scrutineering. After the rally, this kit won't have to be returned and will be able to be used for other trials.

No need to provide any connections, those tracers being self-sufficient for the whole rally.

During the whole rally, any team caught without the tracer or perforating the tracer's protection film will be sanctioned by the officials even leading to an exclusion.

ARTICLE 5P. PUBLICITY

The optional or obligatory advertisers will be communicated by a bulletin during the administrative scrutineering.

ARTICLE 6P. SITES ET INFRASTRUCTURES

6.1P. Description

The 44th Jean De La Fontaine "Ville de Soissons" rally has a total distance of 432,5 km, 304.4 km for the liaison.

2 legs 5 sessions 11 SS: distance 128,1km

Special stages:

Leg 1 – Session 1-2 - SS 1 - 4: Augy (12.6km)

	- SS 2 - 5:	Chivres-Val (8.4km)
	- SS 3-6:	Presles et Boves (13.3km)
Leg 2 – Session 4 - 5	- SS 7:	Mont Notre Dame (8.1km)
	- SS 8 - 10:	Chéry-Chartreuve (12.1km)
	- SS 9 :	Mont Saint Martin (9.3km)
	- SS 11	Mont Notre Dame/ Mont Saint Martin (17.9 km)

A supply park (optional) will be put in place simultaneously to the liaison:

- Before and After SS Mont Notre Dame – Chéry Chartreuve – Mont Saint Martin et Mont notre Dame / Mont Saint Martin

Wheels and fuel may be left there for the competitors only.

Having no available car park, assistance crew members will not be allowed to stay parked after drop-off.

6.2P. RECONNAISSANCE

According to the cross country rally French championship regulation

7.2P General regulations about the controls:

7.2.11P

Marshals will have to be identifiable by distinct signs: Fluorescent safety vests, overalls...etc

7.2.16P

The calculation of any possible standard timing rates will be given by the officials using the geographical localization information. If this data cannot be exploited, regular methods will be used.

7.5.17.1 P

Withdrawals:

7.5.17.2P

Tracers have a “**Panic**” button and can **only be used** in case of **serious medical help** needed.

Teams must be aware that, if activated, the SS will be put on hold and medical help sent immediately.

If this point were not to be respected, teams could be summoned in front of the FFSA disciplinary commission by the chairman and/or officials.

7.6.P Parc Fermé

Cars having no waterproof doors (nets) or SSV cars will be allowed to cover up their cars to protect them from any bad weather.

The cash prizes (a possible **10 285 €** may be handed out)

The grid below shows the prizes expected for a number of 80 competitors.
The amount of the prizes given out will depend on the number of competitors.

Example:

- For more than 100 competitors the amount given out will be equal to the amount indicated + 20%
- For more than 60 competitors the amount given out will be equal to the amount indicated - 20%... etc

- Target time prizes and group prizes can be combined.
- Class prizes are not combinable with target time or group prizes.
- Group and class prizes are granted if at least 5 competitors take part in the group and 3 in the class.
